WHEREAS, a request for bids for the construction remodel of corporate offices at 350 Clover Island Drive, Kennewick was properly advertised with the approved plans and specifications being made available to prospective bidders, and

WHEREAS, the staff and project architect have certified that the lowest responsible bidder for the project is Banlin Construction LLC in the amount of \$143,485.38, plus applicable tax and that such bid is in compliance with the plans and specifications; and

NOW THEREFORE, BE IT RESOLVED that the Port of Kennewick Commission does hereby accept the bid of Banlin Construction LLC for the construction remodel of corporate offices at 350 Clover Island Drive as the lowest responsible bidder in the amount of \$143,485.38, plus applicable tax and hereby awards the construction contract to said low bidder.

BE IT HEREBY FURTHER RESOLVED that the Executive Director is authorized to enter into a contract between Port of Kennewick and Banlin Construction LLC for the construction of said building, and that the Executive Director is further authorized to proceed with all necessary procedures required to complete construction of the project.

Vista Field Redevelopment - Vista Vision Task Force Re:

Tim-

Based on commission direction provided at the commission meeting of May 13, 2014, a draft list of participants was prepared for an advisory committee/vision task force to advise the port related to the Vista Field Redevelopment planning and public participation process. Port staff heard loud and clear that in the event the commission does appoint a committee/task force, it should not infringe upon the opportunity for the public at large to provide any and all comments to the commission or staff throughout the process. In particular, the public will be invited to participate in visioning during the extensive public input process in the fall via the Charrette process.

I believe that a two-step approach may be advisable. First, the commission may want to reach agreement on which organizations, members and/or disciplines (including private citizens) should be invited to participate in the visioning task force. Once the commission reaches agreement on that matter, then it could agree on which individuals should represent the particular member or organization. I suggest this second step take place at a subsequent commission meeting.
