A. Clover Island Inn Update

Mr. Arntzen gave a brief history on the Clover Island Inn and introduced Gurdeep "Zeal" Bains, a group owner of the Clover Island Inn.

Mr. Baines reported last October, they shut down nearly half of the hotel and fully renovated 75 rooms. They are waiting for Hilton to give the rooms final approval and then they will be furnished. Mr. Baines believes they should be ready to go in August and then they will follow the same schedule for the remaining half. Mr. Baines believes the Inn should be in the Hilton reservation system by May 2026. Additionally, Hilton does not want a full-service restaurant in the hotel, and they have been directing all their guests to the local restaurants. Emerald Spark took over the concert series for 2025 and thanked the Port for sponsorship assistance. Although the concert series is not a big money maker, it is great for the community.

B. Kennewick Waterfront Update

Ms. Bader Inglima reported that the Columbia Gardens restroom is being rewrapped and stated the thicker vinyl did not hold up in the sun *(Exhibit A)*.

Ms. Bader Inglima stated staff continues to promote and advertise the lease space at Columbia Gardens. As part of the promotion, Columbia Gardens was featured in an advertorial in Wine Industry Network (<u>https://www.wineindustrynetwork.com/</u>). Ms. Hanchette gave a very informative interview, which featured the space and it is great exposure for the development.

Ms. Hanchette stated every year the Port has a tenant feedback meeting and additional signage was requested for the tasting rooms. Ms. Hanchette worked with High Desert Maintenance, who was able to modify the existing trellis and Mustang Signs added the winery names to the trellis *(Exhibit B)*.

Ms. Hanchette recently had the opportunity to work with Visit Tri-Cities on a fam (familiarization) tour. Ms. Hanchette gave a tour to 11 people, and focused on Clover Island artwork and Columbia Gardens, the artwork, and the vineyard. Visit Tri-Cities worked with Chris at Nana's Kitchen for a late breakfast and an interview. This fam tour allowed Visit Tri-Cities to take part in what the developments have to offer and encourage tourists to visit Columbia Gardens and Clover Island.

Mr. Phongsa stated at the tenant meeting, tenants were pleased with the events but asked for a handout to show where everyone is located. Mr. Phongsa created a notepad for tenants with business listings, a walking map, and other amenities with room for tasting notes *(Exhibit C)*.





Port of Kennewick Plans Additional Testing of Soil at Vista Field Recent samples detect PFAS – no immediate health concerns

KENNEWICK, Wash. –Soil testing on a private commercial lot under construction at Vista Field found levels of PFAS (per-and polyfluoroalkyl substances), above the limit set by Washington State Department of Ecology. The Port of Kennewick plans to take prompt action in response to this new information to confirm there is no threat to human health of the environment.

PFAS are a variety of synthetic chemicals used around the world since the 1950s. PFAs have been found in everyday consumer items like non-stick cookware, water- and stain-resistant products, grease-resistant food packaging, and industrial uses such as firefighting foam and de-icing chemicals.

The Port received the private-sector PFAS environmental report just last week (on June 26, 2025). However, because the Port takes the health and safety of the community seriously, the Port has hired expert consultants to conduct PFAFS soil testing around the affected parcel and more generally within Vista Field to determine if PFAS concentrations are detected.

The Port conducted a Phase 1 Environmental Assessment at Vista Field in 2014 that included extensive evaluation for all pesticides, insecticides, petroleum products and other chemicals listed by the Washington Department of Ecology as hazardous substances. The Assessment identified no conditions of concern. However, Ecology has since expanded its list of hazardous substances to include PFAS.

The Port has hired Blue Mountain Environmental Consulting to take soil samples at Vista Field in mid-July to evaluate the site for PFAS. The Port has also paused construction of additional parking lots and utilities until the sample testing is completed.

The Port's environmental team hopes that the presence of PFAS in the soil is isolated to a small area, but we won't be sure until the test results are available later this summer. The Port is committed to protecting the health and safety of our community and the Port's environmental team is committed to ensuring the study process is transparent and the public and our investment partners are informed once we better understand the nature and scope of PFAS detection at Vista Field.
